QUANTUM BCI FACTOR EQUITY FUND (B)

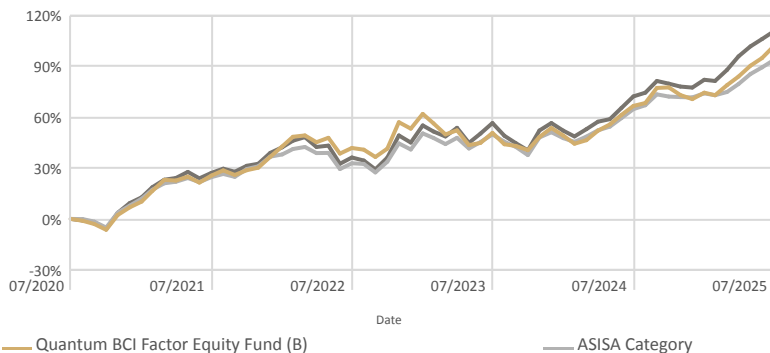
INVESTMENT OBJECTIVE

The fund's objective aims to provide investors with high long-term capital growth that is less volatile than the benchmark.

INVESTMENT POLICY

Investment factor strategies that may be applied, include but is not limited to valuation, quality, momentum and volatility strategies. The portfolio's aggregate equity exposure will be a minimum of 80% of the portfolio's net asset value. The portfolio's investment universe consists of equity securities, preference shares, property shares and property related securities listed on exchanges, interest bearing instruments as well as assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments

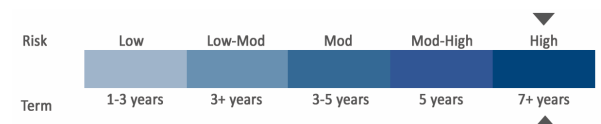
